RE: Announcement of Contract for Professional Design Services

The Athens County Commissioners intend to contract for engineering and architectural services in connection with the Community Development Block Grant (CDBG) Program. Engineering and/or Architectural firms interested in being considered for a contract to provide the required services should reply with a statement of qualifications no later than **February 5, 2010**. Statements received after this deadline will not be considered.

The County is seeking architectural/engineering services for several CDBG-funded projects. Preliminary project descriptions for these projects are attached. A separate statement of qualifications is needed for each project for which a firm is applying. Please provide two copies of each statement of qualifications.

Statements of qualifications should include information regarding the firm's history, experience with relevant projects and references. Please see the attached Instructions to Respondents for further direction. The Instructions to Respondents details the criteria upon which firms will be evaluated. As required by Ohio Revised Code 153.65-71, responding firms will be evaluated and ranked based upon their qualifications. Following this evaluation, representatives of the Athens County Commissioners will enter into contract negotiations with the most highly qualified firm.

**Preliminary Project Description:  
Project #2**

- **Name of Project:** Parks & Recreational Facilities
- **Location:** Village of Glouster
- **Description:** This project consists of installing 7 items of play equipment and a skateboard park at the Glouster Community Park. The skateboard park will be located on an existing tennis court. The park is located in the floodplain and this should be taken into consideration in the design of the project. The Architecture/Engineering scope of work will include project design, preparation of bidding specifications and drawings, review of bids, pre- and post-construction meetings, construction oversight as required, and obtaining all necessary permits. *The grant administrator will prepare the bidding documents and construction contract/s.*
- **Total Project Budget:** \$196,400.00
- **Source of Funding:** Community Development Block Grant Neighborhood Revitalization Program funding and Community Development Block Grant Economic Development Program Income
- **Project Schedule:** All work, including construction, must be completed by December 31, 2010. A reasonable, agreed-upon time frame will be negotiated at the contract signing. Respondents should be prepared to have the project designed and ready to bid within ninety days of award of design contract.
- **Special Requirements or Restrictions:**
  - Meetings with local groups interested in providing input into the design of the project are expected to be required.
  - In responding, please provide specific information regarding your firm's experience with designing skateboard parks as well as general park improvements.
  - All work must meet state and federal guidelines, codes and standards whenever applicable.
  - Davis-Bacon Wage Rates will apply to any construction labor on this project.
  - Hocking Athens Perry Community Action will be responsible for all bidding procedures.
  - For all projects, the County is the "Owner". However, the individual municipalities will be involved in the process.
