EARLY HEAD START & HEAD START



The Head Start and Early Head Start programs serve pregnant women and children from birth to age 5. Program services include center based, home based, and family day care. Comprehensive health, education, and family services are the foundation of the program. Working together with parents, the program provides opportunities to improve school readiness and health outcomes for all children.



The services provided help identify abnormalities or concerns and work with parents to improve outcomes for children. Screenings are routinely completed for all children, and include: vision, hearing, health, developmental, socio-emotional, and dental. With support from the program, families were able to get prompt treatment for their children. Early detection and treatment for health or developmental concerns is critical for all children to be successful. The program provided services to over 1,400 children and families.

Through the Ohio Buckles Program HAPCAP provided car seats, free of charge. The agency provided 76 car seats through this program. An additional 35 car seats were distributed to Trimble school district residents through a Promise Neighborhood grant.



Promise Neighborhood funding was exhausted in June, but through the generosity and support of the local community, the agency was able to continue offering **Promise Play School.**



Meeting weekly at our Glouster office, this program offered families a place to bring young children for play, socialization, and educational opportunities.

EMPLOYMENT SERVICES Almost 400 people



(adults and youth) were given work, job skills, and/or job placement services through HAPCAP's various employment service programs. The Learn and Work Program opened a

second work site offering participants cooking and food safety skills.



Over 150 youth were hired and placed with over 40 community partners to learn valuable work skills in the **Athens Summer Youth Program.**



115 long-term unemployed, dislocated workers, and veterans were given short term employment through the Wind and Flood Recovery Programs. Many were able to obtain employment because of the experience, skills, and training that was gained through employment services.



COMMUNITY SERVICE

HAPCAP has several programs that offer services to mobilize resources and connect individuals and families with much needed community resources. Over 10,000 households were assisted with heating and cooling bills through the **Home Energy Assistance Program** (HEAP), and 52 people were assisted with obtaining a cell phone through the **Safelink Wireless Program**. Through the **Ohio Rural Recidivism Reduction Program** (OR3), Community Action helped provide assistance to ex-offenders re-entering the community and workforce by connecting them with services such as employment, behavioral healthcare, transportation, and housing. 20 participants have completed the requirements of their case plan through OR3.





TRANSPORTATION SERVICES

Safe and reliable transportation services connected individuals with work, health care, shopping, and other resources through our Logan Public Transit, Athens Public Transit, Athens Mobility Management, Athens on Demand Transit, and GoBus programs. These programs provided affordable and accessible transportation for persons with disabilities, elderly, and lowincome populations.

A total of 359,181 rides were provided.

The SE Ohio Foodbank & Kitchen provides access to affordable, quality food resources to those individuals, organizations, and other entities seeking to mitigate food insecurity and promote good nutrition in an efficient, eco-friendly, and sustainable way, thereby supporting the mission and values of Hocking Athens Perry Community Action.



The Foodbank is a distribution center that provides an efficient operation to collect and equitably distribute government, donated, and purchased food to over 60 member agencies throughout 10 Appalachian counties of Southeast Ohio: Athens, Gallia, Hocking, Jackson, Lawrence, Meigs, Morgan, Perry, Vinton, and Washington. The Foodbank distributed 6 million pounds of food (5 million meals), serving on average over 37,000 people each

month through our member network. The Backpack Program provided children on

the school free or reduced lunch program with food items to eat on weekends or long vacations throughout the school year. Over 8,300 backpack were distributed.





FOODBANK

<u>KITCHEN</u> Our Kitchen served over 138,000 meals through our various programs.



The Meals on Wheels Program serves Athens and Hocking counties; and delivered 44,900 hot and frozen meals to senior

citizens in need. There were also 455 bags of pet food delivered to clients for their pets. The Senior Nutrition Program also served over 11,000 meals at 3 congregate senior sites in Logan, Glouster, and Athens.



The Summer Feeding Program expanded to 28 sites, and served over 23,000 meals to children in Hocking, Athens, and Perry counties.



VOLUNTEER PROGRAM

Volunteers donated almost 12,000 hours. Volunteers are very important to our operations.

Special volunteer events and packing events were conducted to pack food boxes and other projects. Individuals, families, groups, or teams also planned special volunteer event.









HAPCAP administers the **Community Development Block Grant** (CDBG) program in our three county service region on behalf of county governments. HAPCAP used these funds to continue to improve the region's infrastructure, including but not limited to, street, curb, and sidewalk improvements, as well as flood and drainage improvements. CDBG is a flexible source of funding used to benefit low to moderate income communities or aid in the elimination of slum and blight.

WEATHERIZATION

The Home Weatherization Assistance Program assists households weatherize their homes. The weatherization program provides an inspection of the home and follows up with appropriate cleaning and tuning of heating equipment, installation of a new furnace or hot water heater, insulation, air sealing, air quality control, and compact fluorescent light bulbs. 233 people in 84 homes were assisted through this program.





Over 750 homes, and serving nearly 2,500 UTILITY ASSITANCE people, were made more energy efficient, and less costly through improvements and upgrades provided through HAPCAP's Utility Assistance Programs. The upgrades includes: compact fluorescent light bulbs, shower heads and aerators for homes with electric hot water heaters, replacement of refrigerators and freezers with more energy

efficient models, installing new furnace, hot water heater, space heaters, attic insulation, wall insulation, floor insulation, air sealing, and energy saving tips to conserve utility usage. These programs were made possible through partnerships with AEP, Columbia Gas, and COAD.



HOME REPAIR and REHAB

Home Repair Programs rehabilitated 75 homes, and provided down payment assistance to families and individuals throughout Hocking, Athens, and Perry counties. These projects were funded through the **Ohio Housing Trust Fund** and the **Community Housing Impact and Preservation Program** (CHIP). The CHIP program, in partnership with Habitat for Humanity constructed a new home as well. With the help of communities and townships, the **Moving Ohio Forward Program**, demolishes houses identified as blights to the community. The houses are surveyed for asbestos and publicly bid out for demolition contract services. 47 such structures were demolished through this program.
