THE FOODBANK ACTS AS A DISTRIBUTION CENTER, BRINGING IN FOOD THAT IS GOVERNMENT FUNDED, DONATED AND PURCHASED, AND DISTRIBUTING IT TO A NETWORK OF FOOD PANTRIES. THE KITCHEN PROVIDES DIRECT CLIENT SERVICE THROUGH SENIOR NUTRITION AND CHILD NUTRITION PROGRAMS, SUCH AS MEALS ON WHEELS AND SUMMER FEEDING.

IN 2020, THE FOODBANK DISTRUTED OVER 5.6 MILLIONS POUNDS OF FOOD AND PREPARED NEARLY 89,406 INDIVIDUAL MEALS FOR SENIORS AND CHILDREN.

OUR EMPLOYMENT PROGRAMS BUILD ON THE STRENGTHS OF EACH PARTICIPANT TO HELP PREPARE THEM FOR THE WORKFORCE. IN 2020, 5,016 HOUSEHOLDS RECEIVED EMERGENCY PROGRAM ASSISTANCE, 310 COMMUNITY MEMBERS WERE SERVED THROUGH OUR EMPLOYMENT PROGRAMS, 98 PARTICIPANTS WERE EMPLOYED BY HAPCAP IN SUMMER EMPLOYMENT.
